**A BILL**

To provide a premium payment to employees who worked without receiving pay during the shutdown of the Department of Homeland Security of 10 percent of the pay the employees should have received during the shutdown.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PREMIUM PAYMENT TO DHS WORKERS RE-**  
4 **QUIRED TO WORK WITHOUT PAY DURING**  
5 **SHUTDOWN.**

6 (a) DEFINITIONS.—In this section:

1           (1) COVERED LAPSE IN APPROPRIATIONS.—The  
2 term “covered lapse in appropriations” means the  
3 lapse in appropriations that began on February 14,  
4 2026.

5           (2) HOURS WORKED WITHOUT PAY.—The term  
6 “hours worked without pay”, with respect to an un-  
7 paid employee, means any hours worked by the un-  
8 paid employee during the covered lapse in appropria-  
9 tions for which the unpaid employee did not receive  
10 pay during the period of the covered lapse in appro-  
11 priations.

12           (3) UNPAID EMPLOYEE.—The term “unpaid  
13 employee”—

14           (A) means an employee—

15                   (i) employed by an agency affected by  
16 the covered lapse in appropriations;

17                   (ii) who performed work for the agen-  
18 cy described in clause (i) during the cov-  
19 ered lapse in appropriations; and

20                   (iii) who did not receive pay for any  
21 of the work described in clause (ii) during  
22 the period of the covered lapse in appro-  
23 priations; and

24           (B) does not include an employee of an  
25 agency affected by the covered lapse in appro-

1           priations who received pay during the period of  
2           the covered lapse in appropriations for any of  
3           the work performed by the employee during the  
4           covered lapse in appropriations.

5           (b) PREMIUM PAYMENT.—Not later than 1 day after  
6 the end of the covered lapse in appropriations, the head  
7 of each agency employing unpaid employees shall make a  
8 1-time payment to each unpaid employee of the agency  
9 in the amount equal to 10 percent of the product obtained  
10 by multiplying—

11           (1) the number of hours worked without pay by  
12           the unpaid employee; by

13           (2) the hourly rate of basic pay of the unpaid  
14           employee.
